- **Registration forms must be returned by the end of June.**
- **All entries must register at the parade registration table at 5th and Martin Streets (which may be accessed via Champion St) beginning at 11:30 AM. Upon check-in, a parade official will direct you to your parade line-up position.**
- **Do not park your private vehicle in the staging area.**
- **The parade will start moving at 1:00 P.M.**
- **A large banner or sign that our announcer can easily view must identify each entry.**
- **Except for one brief stop at Lafayette and Wilkes Streets, no stopping on the parade route unless the entire parade is stopped.**
- **All livestock entries must be followed by a dedicated "pooper scooper."**
- **Only candy or balloons may be handed out (not thrown) during the parade procession.**
- **Parade participants must follow instructions of parade staff in regards to rules, regulations, placement and movement along the parade route. The parade committee reserves the right to bar at any time any participant who fails to observe the rules or follow instructions of parade officials.**

*Directions to Staging Area: Drive West on Steilacoom Blvd. Stay on Steilacoom Blvd. while it curves around through the trees and becomes Rainier heading South. Turn left on Union, then right on Champion Street. Make a right turn on 5th and look ahead for the parade registration desk.*
